





DISCOVER OUR PARKS

BELAIRE PARK 18500 SW 97 Avenue • Bel Aire Park is a 5-acre park that is the home of the Palmetto Raiders Youth Development Club football and cheerleading programs.

BLUE HERON PARK

21900 SW 97 Avenue • Blue Heron Park sits adjacent to one of the many -made lakes in the Lakes by the Bay Community. The park includ a well-shaded ½ mile long paved multi-use path popular with walkers, joggers and bicyclists.

CUTLER RIDGE PARK AND POOL

10100 SW 200 Street • Cutler Ridge Park and Pool is home to the Cutler Ridge Soccer Club, the Riptides Swim and Water Polo teams and Homestead Wahoos Swim Club. The park consists of a recreation building swimming pool, athletic fields, picnic pavilion, and covered playground.

FRANJO PARK 20175 Franjo Road • Franjo Park is the long-time home of the Perrine Baseball and Softball Association.

LAKES BY THE BAY PARK

8551 SW 216 Street • Lakes by the Bay Park park consists of three baseball/ softball fields, 4 batting cages, 2 soccer/football/lacrosse fields, a 0.6 mile exercise path, covered playground and concession building.

LINCOLN CITY PARK

SW 212 Street & SW 99 Avenue • Lincoln City Park is a natural area with an abundance of native species including live oak and slash pines.

SAGA BAY PARK

8000 SW 205 Street • Saga Bay Park contains 4 lighted tennis courts, a covered playground, a paved walking path with outdoor exercise equipment

SAGA LAKE PARK SW 198 Street & SW 83 Avenue • Saga Lake Park contains a picnic pavilion, a paved fitness path and a practice baseball/softball field.

WHISPERING PINES PARK

8800 Ridgeland Drive • Whispering Pines Park is adjacent to Whispering Pines Elementary School and the Ned Glenn Preserve this park cont a covered playground and picnic pavilion. It is the gathering point for the annual Whispering Pines 4th of July Parade.
